ARTICLE I

Name of Corporation

The name of this corporation is EFNA GULFSTREAM INC..

ARTICLE II

Purpose

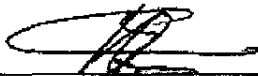

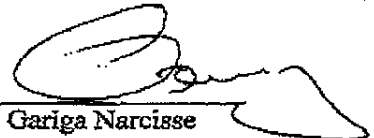
ARTICLE X

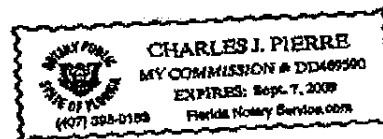
