ARTICLES OF INCORPORATION

OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as incorporators in adopting and filling the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Storm Ready Systems, Inc.

ARTICLE II

The existence of the corporation shall begin on January 12, 2006. EFFECTIVE DATE

ARTICLE III
