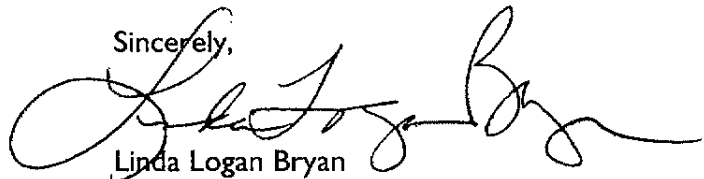

**ARTICLES OF INCORPORATION
OF
JAI BHUVANESWARI MAA, INC.**

The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I

NAME

The name of the corporation is JAI BHUVANESWARI MAA, INC.

II

DURATION

The duration of the corporation shall be perpetual.

III

CORPORATE PURPOSE

The general purpose for which the corporation is organized is to own and operate a motel/hotel, and to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, and to do all the things as are necessary or desirable in order to accomplish the foregoing.

IV

SHARES (STOCK)

- A. The aggregate number of shares which the corporation is authorized to issue is One Hundred (100) shares. Such shares shall be of a single class, and shall have no (\$0.00) par value.

- B. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
- C. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than seventy-five (75) persons. Stock will be issued and transferred to only (1) natural person(s) (2) estates, or (3) a qualified subchapter S trust (QSST) as described in title 26 United States Code Section 1361 defining a qualified "small business corporation." In addition, no stock shall be issued or transferred to a nonresident alien.

V

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the corporation's principal office and for its mail is 601 Anastasia Boulevard, St. Augustine, Florida 32080.

VI

DIRECTORS

- A. This corporation shall have at least one (1) but no more than five (5) directors. The number of directors shall be determined as provided by the corporate by-laws, and these directors shall be elected in accordance with the provisions of the corporate by-laws adopted by the stockholders, as amended from time to time in accordance with the procedures provided in the by-laws.
- B. The number of directors constituting the initial Board of Directors of the corporation is two (2). The names and addresses of the people who are to serve

as the members of the initial Board of Directors is:
