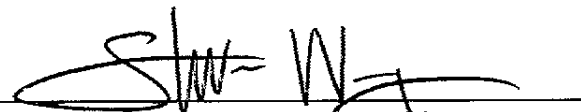
SECOND: The date of the adoption of these Articles of Dissolution is 12 July 2006.
