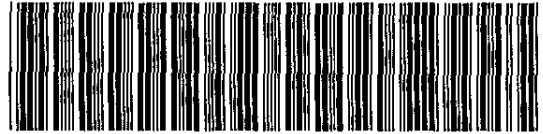

ARTICLE I.

NAME

The name of this corporation is Gulfcoast Medical Care and Geriatrics, Inc.

ARTICLE II.

AMENDMENT

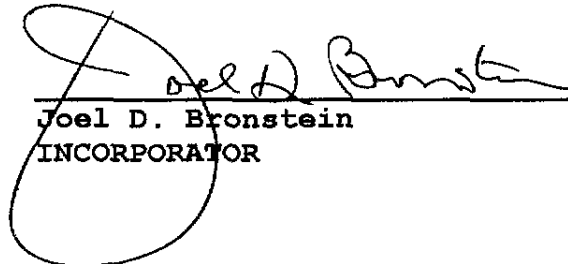

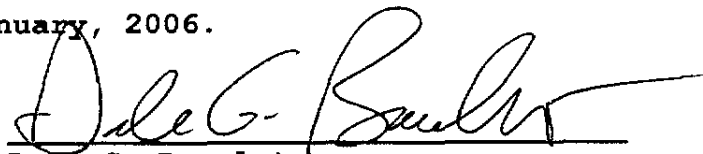
