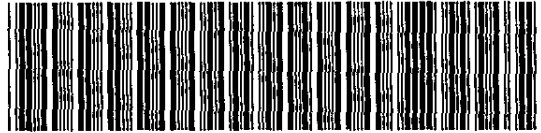

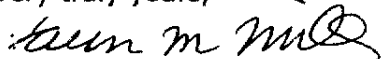

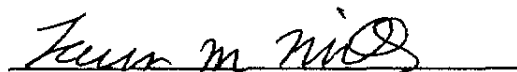

ARTICLE IX. AMENDMENT

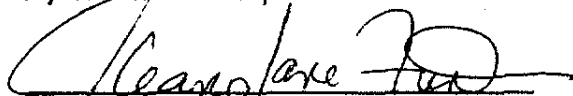

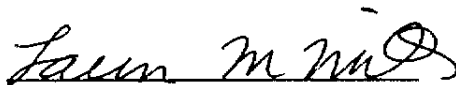
