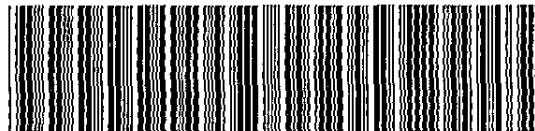

# **ARTICLES OF INCORPORATION**

## **OF**

### **ROBERT SEELEY'S SCREEN REPAIR, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### **ARTICLE I: NAME**

The name of the Corporation is: ROBERT SEELEY'S SCREEN REPAIR, INC.

#### **ARTICLE II: DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

#### **ARTICLE III: PURPOSE**
