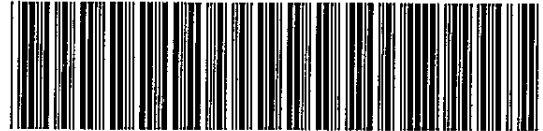

ARTICLE X
