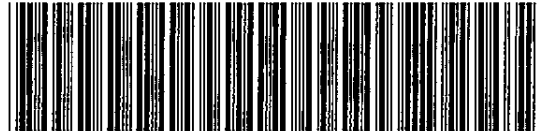

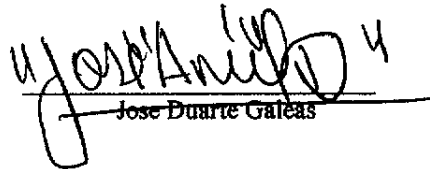
**ARTICLE X- INDEMNIFICATION**

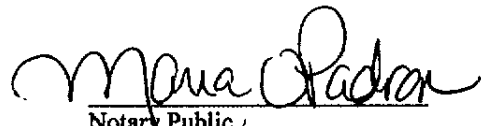
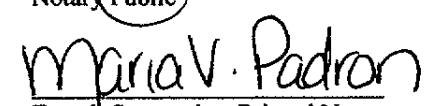

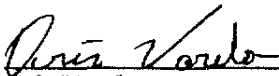
