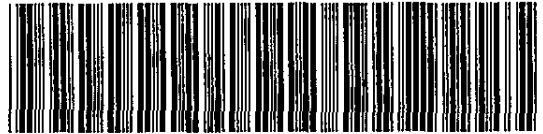

OF

ARTICLE I.

CORPORATE NAME

The name of this corporation is EMPTY PAIL PAINTING COMPANY.

ARTICLE II.
