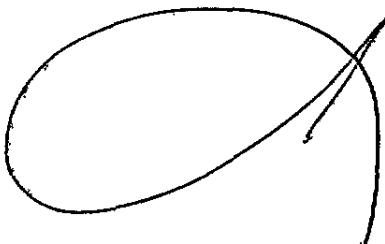

ARTICLE I - NAME

The name of this corporation is: David Saketkoo, Psy.D., P.A.

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the specific purpose of rendering psychological and psychotherapy services; nevertheless, it shall be authorized to transact any or all lawful business as provided by Florida Statutes, Chapter 621, "Professional Service Corporation and Limited Liability Company Act.", as it exists on the date hereof or as it may hereafter be amended.

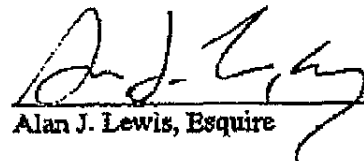
