ARTICLES OF INCORPORATION

OF

J. BROWN'S PAINT, INC.

ARTICLE I - NAME

The name of this corporation is J. BROWN'S PAINT, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.


