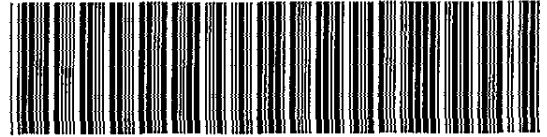

FIRST: The name of the corporation is Ag Pro, Inc.

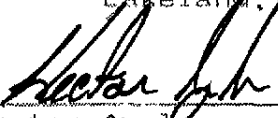

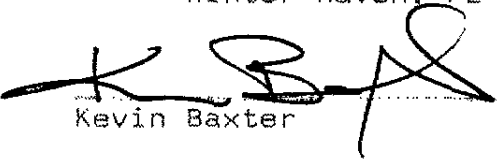
