Pursuant to the provisions of Section 607.1006, Florida Statutes, SenTech Acquisition Corp., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Corporation's Articles of Incorporation has been amended to read as follows:

"ARTICLE I

The name of this Corporation shall be: SenTech Medical Systems, Inc."

SECOND: The foregoing amendment was adopted on February 15, 2006.

THIRD: The foregoing amendment was approved by the stockholders of the Corporation. The number of votes cast for the amendment was sufficient for approval. There were no voting groups entitled to vote separately on the amendment.
