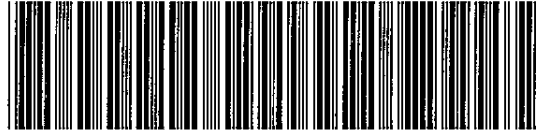

ARTICLES OF INCORPORATION

FOR

Rothschild Goldman Real Estate Corp.

ARTICLE I - NAME

The name of this corporation shall be Rothschild Goldman Real Estate Corp.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE VIII - PRINCIPAL OFFICE ADDRESS
