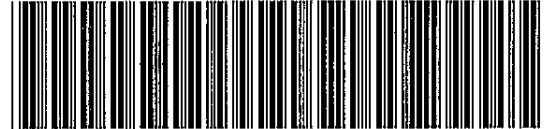

ARTICLE I - NAME

The name of this corporation is **EXPERIENCED MARKETING, CORP.**, (hereinafter, "Corporation").


ARTICLE X-SHAREHOLDERS MEETING REQUIRED
