ARTICLE I – NAME

THE NAME OF THIS CORPORATION IS:


ARTICLES XI – PRE- EMPTIVE RIGHTS

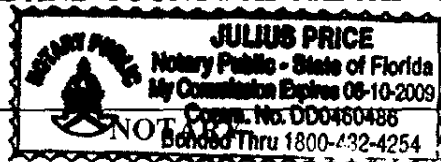

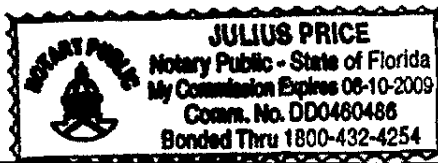
