**ARTICLES OF INCORPORATION
OF

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Bonsai Downtown, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on January 19, 2006 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
