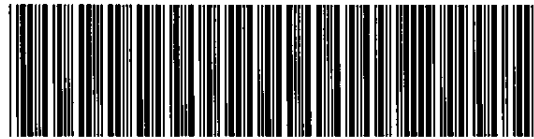


SECOND: The date of the adoption of these Articles of Dissolution is 13 December 2006.
