NAME

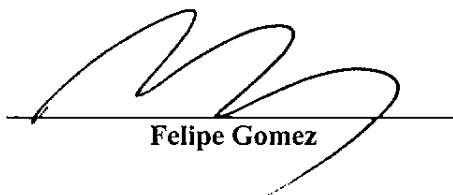
