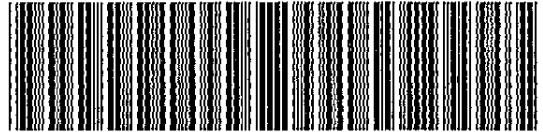

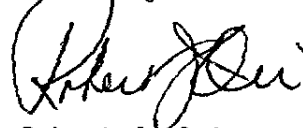

The undersigned, acting as the incorporator of a corporation under the Florida Corporation Act, adopt the following articles of incorporation for such corporation.

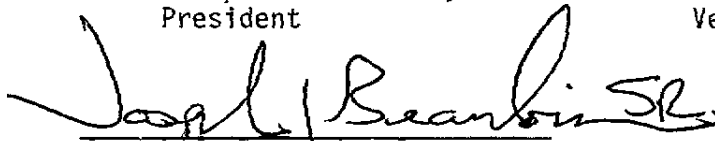
1. The name of the corporation is Joseph J. Beaudoin, Inc.

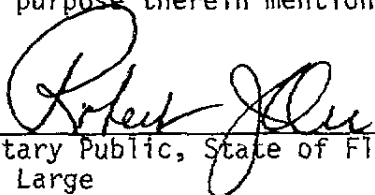
