The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name, Location and Mailing Address of Principal Office

The name of the corporation is ALEXANDER CLIMBING, INC. The principal office and mailing address of this corporation is 489 Starratt Road, Lot 263, Jacksonville, Florida 32218.

ARTICLE II Purpose
