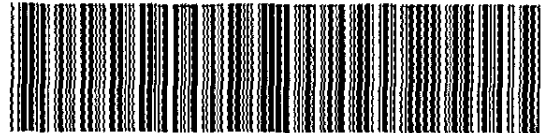

OF





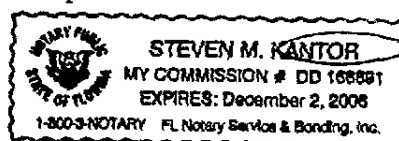
