

**ARTICLES OF INCORPORATION



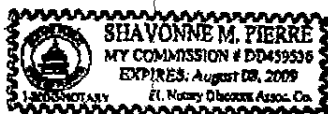


