ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Algree, Inc. Its principal office address and business mailing address is 1320 South Dixie Highway, Suite 781, Coral Gables, Florida 33146.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
