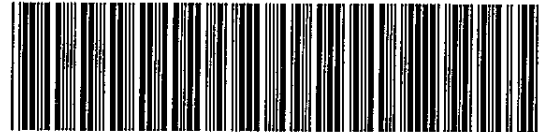

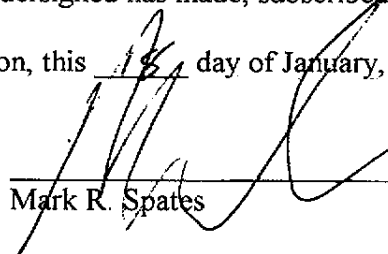
ARTICLE IX

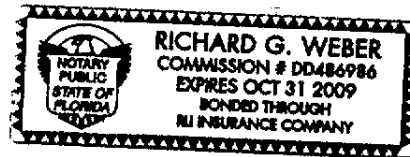
