ARTICLES OF INCORPORATION OF MILLWORK PARTNERS INTERNATIONAL, INC.

The undersigned incorporator, a natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act:

Article L. Name

The name of the corporation (the "Corporation") shall be MILLWORK PARTNERS INTERNATIONAL, INC.

Article II. Principal Office and Mailing Address

- 4.1 <u>Authorized Shares</u>: The total number of shares of capital stock that the Corporation has the authority to issue is 11,000 shares; consisting of 10,000 shares of common stock \$.01 par value and 1,000 shares of preferred stock, \$.01 par value.
- 4.2 <u>Rights for Preferred Shares</u>: The board of directors is expressly authorized to adopt, from time to time, a resolution, or resolutions providing shares in each such series and to fix the designations and powers, preferences and relative, participating, optional and other qualifications, limitations and restrictions of such shares, of each such series.
- 4.3 <u>Denial of Preemptive Rights</u>: No holder of any shares of the Corporation of any class now or in the future authorized shall have any preemptive right as such holder (other than such right, if any, as the board of directors in its discretion may determine) to purchase or subscribe for any additional issues of shares of the Corporation of any class now or in the future authorized.

determined that such person is not entitled to indemnification by the Corporation under paragraph 11.1 above.

This Corporation expressly elects not to be governed by the provisions of Section 607.0901 of the Florida Business Corporation Act, as amended from time to time relating to affiliated transactions.
