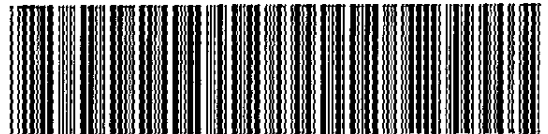

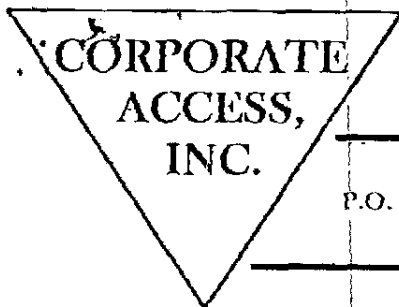

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - Name

The name of this Corporation is **TIMBUK2 SOLUTIONS, INC.** The principal place of business of this Corporation shall be 3222 Paul Avenue W., Tampa, Florida 33611 or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

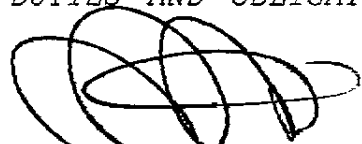
