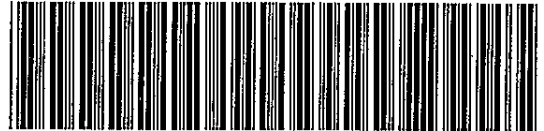

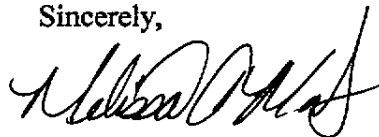

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. Name. The name of the corporation is D&M ELECTRONICS & COMPUTERS, INC.

2. Duration. The period of its duration if perpetual.
