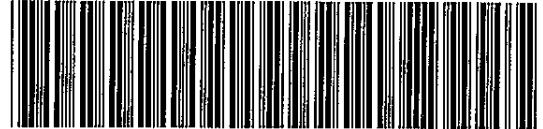

**THESE ARTICLES OF INCORPORATION** are signed by the incorporator for the purposes of forming a profit corporation pursuant to the provisions of Florida Statutes Chapter 603, as amended, as follows:

**ARTICLE I**

The name of the corporation is UNI SRQ, INC.

**ARTICLE II**

The purpose for which the corporation is formed is to engage in any activity within the purposes for which corporations may be formed.

**ARTICLE III**

The street address of the principal office of the corporation is 9824 Immokalee Road, Naples, Florida 34120. The mailing address of the corporation is 15275 Collier Blvd., Unit #201, PMB 122, Naples, Florida 34119.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 10,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
