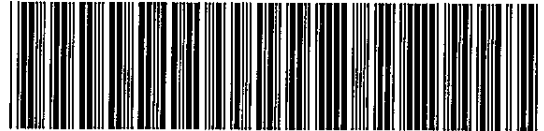

**ARTICLES OF INCORPORATION
OF
TNT FORKLIFT SERVICE CORP.**

ARTICLE I - NAME

The name of this corporation is TNT FORKLIFT SERVICE CORP. (hereinafter, "Corporation").

ARTICLE II - PRINCIPAL PLACE OF BUSINESS ADDRESS


ARTICLE X-SHAREHOLDERS MEETING REQUIRED
