

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is THE MAGNOLIA TREE OF WAUCHULA, INC.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose, and nature of business to be transacted by this corporation is to own and operate a retail and accessory store, as well as any other activity or business legally permissible under the applicable laws of the State of Florida or the United States of America.
