

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator for the purposes of forming a corporate business under the laws of the State of Florida, adopts the following Articles of Incorporation for such Professional Association.

ARTICLE ONE

The name of the corporation is: Minesh Patel, M.D. P.A..
