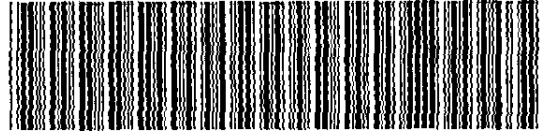

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I - Name**

The name of this Corporation is **CRC ACQUISITIONS CORPORATION**. The principal place of business of this Corporation shall be 3933 Doral Drive, Tampa, FL 33634 or such other place as may be designated by the Board of Directors.

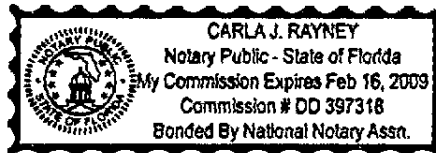
