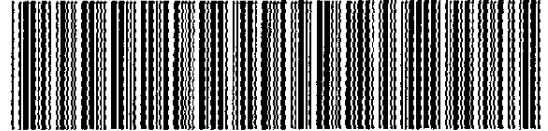

**ARTICLES OF INCORPORATION
OF

Pursuant to the provision of the laws of the State of Florida, the undersigned hereby adopts the following Articles of Incorporation to organize the professional corporation described below (the "Corporation").

ARTICLE I

The name of the corporation shall be:

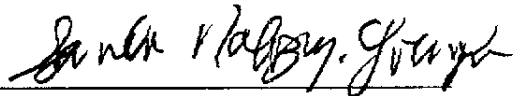
