The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

The name of the corporation shall be: TAMPA PRIME, INC.

Article II

The initial principal place of business and mailing address of this corporation shall be: 2815 Turkey Creek Rd. Plant City, Florida 33566. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it see fit.


