The undersigned acting as the Incorporator under Florida Business Corporation Act, adopts the following articles of incorporation for such corporation:

# ARTICLE I - CORPORATE NAME

The Name of the corporation is:

This corporation shall exist perpetually unless dissolved according to Florida Law.

# ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and Florida.

The corporation is authorized to issue 10 shares of common stock, par value \$100.00 per share.

Such written consent or consents shall be held with the minutes of the proceedings of the Board, and any such action by written consent shall have the same force and effect as if taken by vote of the Directors. Any certificate or other document filed under any provision of law which relates to actions so taken shall state that the action was taken by written consent of the Board of Directors without a meeting.
