

ARTICLES OF INCORPORATION
OF
LAKE GENEVA PEDIATRICS INC.

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("the Corporation") is LAKE GENEVA PEDIATRICS INC.

ARTICLE II

The street address and mailing address of the principal office of the Corporation is 4725 SW 88th Drive, Gainesville, Florida 32608.

ARTICLE III

The Corporation is authorized to issue Fifty Thousand (50,000) shares of common stock having a par value of One Cent (\$.01) per share.

ARTICLE IV




The Corporation shall indemnify its directors and officers to the fullest extent permitted by law.
