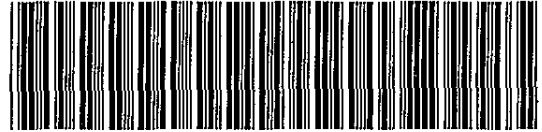

The undersigned, David Z. Lu, whose post office address is 8500 Leesburg Pike, Suite 410, Vienna, VA 22182, being at least eighteen years of age, intends to form a stock corporation under the general law of the State of Florida and Chapter 607 or 621 F.S.

**Article One  
NAME**

The name of the Corporation (which is hereinafter called the Corporation) is **Confidente One, Inc.**

**Article Two  
PRINCIPAL OFFICE**

The post office address of the principal registered office is 15040 Norfolk Lane, Davie, FL 33331.

**Article Three  
PURPOSE**

The purpose of the Corporation is to carry out any, and any and all lawful business permitted by the laws of the State of Florida.

**Article Four  
STOCK**

The total number of shares of Stock, which the Corporation shall have authority to issue, is 100,000 shares with the par value of \$10.00 a share, all of one class, that is common stock, having an aggregate par value of \$1,000,000.00.

**Article Five**  
**INITIAL REGISTERED AGENT**

For the purposes of defining, limiting and regulating the powers of the Corporation and of the directors and members, the By-Laws shall be the governing source of authority.


