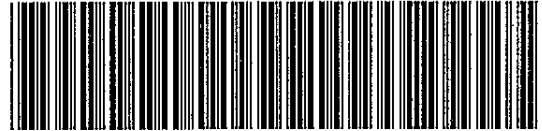



WE, the undersigned subscribes of these Articles of Incorporation, both natural persons, competent to contract and desiring to form a Company under the Laws of the State of Florida, hereby certify as follows: STATE OF FLORIDA

**ARTICLE I**

The name of the proposed company is **Vic-Car Enterprises Corporation.**

The Company may engage in activity or business permitted under the Laws of the United States of America and the State of Florida.

**ARTICLE III**

The maximum number of shares of stock, which the company is authorized to have outstanding at any time, shall be 100 shares of common stock, with a par value of \$1.00 per share.


