

ARTICLES OF INCORPORATION OF MUSCULOSKELETAL EXCELLENCE, INC.

OS MAN ON STATE The undersigned subscriber to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.
