

ARTICLES OF INCORPORATION

OF

FIRST COAST CUSTOM DRYWALL, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formulation, liability, rights and privileges and immunities of a corporation for profit.

ARTICLE I- NAME

The name of the corporation shall be FIRST COAST CUSTOM DRYWALL.

ARTICLE II- OFFICE

The principal office of this corporation shall be situated at 10888 I-IPPIZAN DRIVE JACKSONVILLE, FLORIDA 32257 and said corporation shall have the rights and privileges of business in such states of the United States and Foreign countries whenever the Board of Directors may from time to time order and establish.

ARTICLE III- REGISTERED AGENT

The street address of this corporation's initial registered office will be 10888 LIPPIZAN DRIVE JACKSONVILLE, FLORIDA 32257 and the name of its initial registered agent will be DANIEL L. ASHE at such address.

ARTICLE IV- NATURE OF BUSINESS

The nature of the business and the purposes to the transacted are to engage in and to have unlimited power to do any lawful act concerning any of all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Law.

ARTICLE V- CAPITAL STOCK
