

ARTICLES OF INCORPORATION

OF

We, the undersigned, MTCHAEL JOHNSON and LISA G. JOHNSON, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.

- 1. NAME. The name of the corporation shall be TROPICAL TWISTERS, INC. a Florida corporation.


