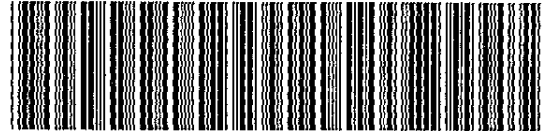

ARTICLE I.
CORPORATE NAME

The name of this Corporation shall be:

ARTICLE II.

ARTICLE III.
NATURE OF CORPORATE BUSINESS
