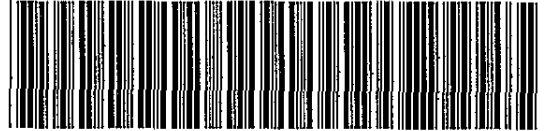

Identification


