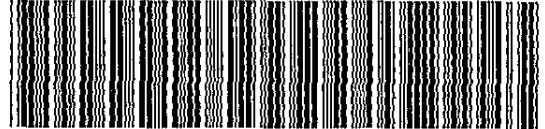

**ARTICLES OF INCORPORATION  
OF  
GO FIGURE! OF LAKE COUNTY, INC.**

**THE UNDERSIGNED**, acting as sole incorporator of GO FIGURE! OF LAKE COUNTY, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

### **Initial Board of Directors**



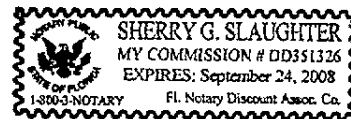
