We, the undersigned, hereby associate ourselves together for the purpose of becoming a Corporation under the Laws of State of Florida, under the provisions of the Chapter 607 of Florida Statutes, providing for the formation, liability, rights, privileges and immunities for a Corporation, for profit, generally, and hereby make, subscribe, acknowledge and file this Certificate for the purpose of becoming a Corporation under the Laws of the State of Florida.

### ARTICLE ONE

Name of the Corporation

The Name of the Corporation shall be:

EASY COFFEE LOVERS, INC.

#### ARTICLE TWO

Nature of Business

The general nature of business to be transacted by this corporation shall be: Any activity and business permitted under the Laws of the State of Florida including but not limited to import and distribution of coffee products.

## ARTICLE THREE

Capital Stock

The maximum number of shares of capital stock authorized to be issued by this Corporation shall be 800 shares, each having a par value of \$1,00 per share. Each of said shares of stock shall entitle the holder thereof to 1 (one) vote at any meeting of the stockholders.
