#### ARTICLES OF INCORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I.

The name of the corporation is OPEN MRI EQUITY PARTNERS, INC.
