**ARTICLES OF INCORPORATION
OF**

ACAS-Denver, Inc.

ARTICLE I

The name of the corporation is ACAS-Denver, Inc. (the "Corporation").

ARTICLE II

The street address of the Corporation's initial registered office is CT Corporation System, 1200 South Pine Island Road, Suite 250, Plantation, Florida 33324.

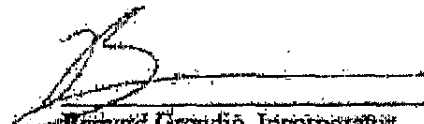
ARTICLE V
