**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, this Florida Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

2. The original Articles of Incorporation for the corporation were filed effective January 26, 2006, and assigned Document No. P06000013092.
3. The Articles of Incorporation are amended as follows:

- b. Article II of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

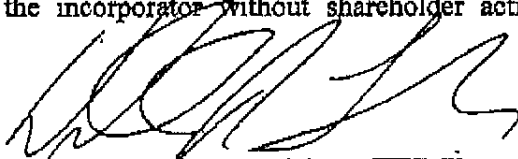
**ARTICLE II
